a) Background:

The Kenya Deposit Insurance Corporation (KDIC) is a statutory institution established under the KDIC Act, 2012. The Corporation, under the National Treasury is the country's Resolution Authority for banks mandated to promptly resolve problem banks in respective of which it has been appointed receiver or liquidator; provide a deposit insurance scheme for customers of member institutions and provide incentives for sound risk management.

b) About the KDIC Youth Internship

The objective of the KDIC Youth Internship is to provide the youth with an opportunity to gain practical experience in their respective fields and develop their ability to successfully take up employment opportunities. *The internship shall be for a nonrenewable one (1) year period.*

c) Who is Eligible to apply?

The persons eligible for this program shall:

1. be unemployed Kenyan graduates from recognized training institutions who have completed their degree courses within the last three year;
2. not have been exposed to work experience related to their area of study;
3. be graduates of degree and diploma programs;
4. not have retired or exited from formal employment; and
5. not have benefited from a similar program.
