Basic Requirements

1. Attachment:

- i. Application letter;
- ii. Must be on-going student;
- iii. Copies of Academic Transcripts;
- iv. Recommendation letter from the learning Institution;
- v. Be a Kenyan youth between 21 years to 34 years of age;
- vi. A copy of National Identification Card;
- vii. Medical Insurance cover by the National Hospital Insurance Fund (NHIF) and WIBA cover.

Eligibility and duration of Attachment;

- The attachment will be three (3) months strictly nonrenewable contract;
- Must be on-going students

Other requirements the successful candidates will be required to have in line with the Attachment Policy and Guidelines for the Public Service:
